

Notice of COVID-19 Vaccination

Receiving your vaccination

- **Vaccination is not mandatory.** If you agree to the vaccination after understanding the effects, side effects, and the Relief System for Injury to Health with Vaccination, you may receive the vaccination.
- Please read the attached “Instructions for COVID-19 Vaccination” before deciding whether or not to receive the vaccination. Please note that the instructions for Pfizer and Moderna versions are enclosed.
- If you are worried about vaccination due to a chronic condition, or are currently receiving medical treatment, please consult your doctor in advance.
- As a rule, you may be vaccinated if your health is in good condition. But, if the doctor decides to forgo the vaccination, you cannot be vaccinated.
- In principle, the presence of a parent or guardian is required for vaccination of anyone under 16 years old.

- The make of vaccine may be different at each vaccination site. Please refer to the Yamato City or appointment websites to see which vaccine is being used.
- Please refer to the “List of Cooperating Medical Institutions for Yamato City’s COVID-19 Vaccination” (A3 size)
- Attendants can also enter.

■ Reservations Please note that reservations differ according to the type of vaccination: Individual Vaccination, Group Vaccination, or Yamato Model.

- Please have your vaccination ticket ready.
- Please fill in the Pre-vaccination Screening Questionnaire at home in advance.
- Please be aware that depending on the situation, such as the rate of vaccine supply and the vaccination progress, you may have difficulty making an appointment immediately after receiving your vaccination ticket.

- Please make a reservation through one of the following methods.

- ① City website (Yamato City website or QR code on the right)
- ② COVID-19 Vaccination Call Center (046-260-0900)

- **Vaccination start dates** Start dates vary depending on the age group, etc.

- **Vaccination period** Until February 28, 2022

- **Vaccination frequency and interval** (As of July 1, 2021)

- ◇ Pfizer: Two doses, 3 weeks apart, over 12 years old (born before April 1, 2010)
- ◇ Moderna: Two doses, 4 weeks apart, over 18 years old (born before April 1, 2004)

- Vaccination intervals vary depending on the maker of the vaccine.
- Receiving multiple vaccines simultaneously is not recommended. If you are planning to get a vaccination other than the COVID-19 vaccine at about the same time, please wait for more than two weeks between doses.
- Vaccines for both doses should be of the same maker.

- **Vaccination fee** Free of charge



- **Things to bring on the vaccination day**

- Vaccination envelope (yellow)
- Vaccination ticket
- Pre-vaccination Screening Questionnaire (corrections with white-out tape, etc., is not allowed. Please fill in the questionnaire with a black or blue ballpoint pen and bring it with you.)
- Identification document (health insurance card, driver's license, etc.)
- If you have other items, such as a prescription drug record, maternal and child health handbook, thermometer, or reading glasses, please bring them with you.

If you have lost your vaccination ticket, please contact the **COVID-19 Vaccination Call Center (046-260-0900)**.

Please wear loose-fit clothing, such as a t-shirt that can be rolled up over your shoulder, for your appointment.

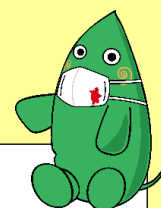
- **Requests from vaccination sites**

- ① Please follow anti-virus measures by wearing a mask, sanitizing your hands, ventilating your room, and avoiding crowded places and close-contact settings.
- ② To prevent the spread of COVID-19, the following people should be vaccinated only after their physical condition has recovered:

- Those who have persistent cold symptoms
- Those who have had a fever within the last 2 weeks (body temperature higher than normal, or a body temperature that is 37.5 degrees Celsius or above)
- Those who have visited any of the foreign countries specified by the Ministry of Justice and the Ministry of Health, Labor, and Welfare within the last 2 weeks (and those who have been in close contact with them—home or work.)
- Those who have a history of contact with COVID-19 patients or suspected cases (including fever at home or in the workplace)
- Those who may have had close contact with COVID-19 patients and are in quarantine (including self-isolation)
